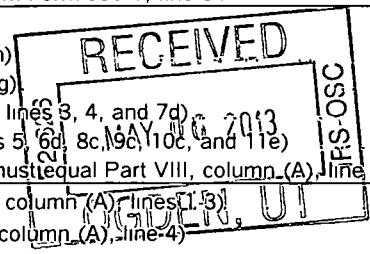

Through Lund's Residential Treatment Program 84 mothers and 91 children engaged in gender-specific, family-centered substance abuse and mental health treatment. Additionally, 184 mothers and children benefitted from SA & MH treatment in the community.

100% of babies born at Lund were free of illicit substances, and were of normal gestation period and birth weight.

Of the mothers discharged from treatment in FY12:

- 61% decreased frequency of use;

- 48% improved functioning.

Service Areas and Target Population:

Lund helps families break cycles of abuse, poverty and addiction. With over 120 years of service to Vermont's children and families, Lund helps children thrive through programs supported by enduring public-private partnerships. Lund's services to the community are integrated and family-centered. Young pregnant and parenting women and their families access our continuum of services depending on their needs and eligibility. A family often benefits from multiple Lund services.

Lund creates and strengthens families by finding adoptive homes for children in state custody and infants. We provide comprehensive, gender-specific residential and outpatient treatment and supports to families affected by substance abuse and mental health disorders. Our Early Childhood Program stimulates vital early brain development and school readiness in at-risk children. We prepare young mothers to provide for their families through our educational, parenting, life skill, and job training services.

Lund's target population is pregnant and parenting young women between the ages of 14-28, and their families. 80-90% of our families are economically disadvantaged at 185% or more of the Federal Poverty Guidelines. The majority of families served by Lund have incomes below \$10,000 a year. Most of the mothers engaged in treatment services have experienced significant trauma. Many of the women have had fragmented and disorganized family relationships, and have been socially isolated and alienated due to these and other problems. Their families are at-risk of neglect, abuse and school failure.

Lund provides a continuum of Family Support and Education Services.

Lund's Early Childhood Education program ensured 66 children at risk of abuse, neglect and school failure enjoyed high quality early education and care. While they were enrolled their families were connected to needed resources and services in the community. Our Early Childhood Program serves a population with a high level of needs: 90% of children living in poverty and at risk of school failure; 82% of children living in single female-headed families.

Our New Horizons Education Program provided high school completion and postsecondary readiness to 47 pregnant and parenting teens and young women. In New Horizons, 9 received their High School Diploma and 7 received their GED in FY12. Other young mothers continued on the program into the next Fiscal year or transitioned successfully back to their high schools.

538 families agency wide were referred & connected to community resources & services.

184 families benefitted from family education & parenting skills, both in the community and in residence.

95 mothers received educational, job training, life-skills & transitional housing services.

Lund's Adoption Program finalized adoptions for 210 children, including 183 children previously living in foster care and 27 infants private adoptions. These 183 foster child adoptions will save Vermont \$4.8M in out-of-home placement costs in FY13.

Other results of the Adoption Program at Lund were:

- 42 birth mothers received counseling.
- Comprehensive post-permanence services were provided to 142 families.
- 1,500 individuals received Search and Reunion services.

Lund's Adoption Program is committed to finding children permanency in the least possible time. In FY12 the following outcomes were achieved:

- 80% Project Family adoptions move from custody to TPR in < 24 mths.
- 47% Project Family adoptions move from TPR to adoption in < 4 mths.
- 64% Project Family adoptions move from custody to adoption in < 24 months.
