The Society houses local historical material in its museum pertaining to Dorset, VT which it displays on a revolving basis, sponsors various guest speakers who make presentations of historical interest, and provides a resource for Dorset students and residents to do research on topics of interest to them. The Society also keeps the town records for future reference. To do all this by non-salaried volunteers costs over \$35,000 to \$40,000 per year.
