Wuqu' Kawoq is a non-governmental organization committed to facilitate excellence and linguistic competence in medical care delivery in the indigenous highlands of Guatemala. Programs include primary care systems development, support of community health workers, community development, and literacy and education.

Nutritional Programs: We are currently administering nutritional programs in approximately 100 communities within Guatemala. These services include medical monitoring of children for health and growth parameters, providing medical services as required, providing a variety of nutritional and food supplements to at-risk children, and providing ongoing community education and followup. Total children currently receiving supplements through these programs is approximately 6,000. All services and products are provided without charge and local community programs are administered by a combination of Guatemalan staff and community volunteers.

4b (Code:) (Expenses \$ 36,592 including grants of \$ 0) (Revenue \$ none)

Medical Clinic Services: We are currently providing medical services to the local communities at 15 sites. These include two permanent clinic locations with the balance being satellite sites. In the last program year we provided medical services for about 10,000 patients. We maintain ongoing relationships with health care providers and hospitals in Guatemala and referred about 500 patients for specialized screening, laboratory, or medical services. We also maintain partnerships with the Guatemalan Ministry of Health and about ten other non-governmental agencies providing similar or complementary services in Guatemala. All services are provided without charge.

Language Revitalization: We sponsor an annual in-country intensive language program in the primary Mayan language within our service area. We also sponsored linguists in the production and compilation of new Mayan words to describe current medical and scientific terms to aid in community education and overall comprehension of medical services. We have published several health and community educational pamphlets and training materials in Spanish and Mayan. We continue programs to provide services in the local indigenous languages and to document and publish in the indigenous languages to further preserve their use.

ACOTCHI Midwife Training and Support: We provide training in new techniques and medicines to a midwife cooperative in Guatemala. This is now our fourth year of partnership. In a typical year we provide education for 100 midwives, start the development of 15 new midwife candidates, and hold about 100 annual training sessions on a variety of topics. ACOTCHI serves approximately 4,000 midwife visits per year. Support of ACOTCHI is primarily through a Conservation Food and Health Foundation grant that we successfully solicit and administer.

Expenses \$15,118 including grants of \$0 Revenue: None

Through support obtained through donors, affiliation with several Rotary Clubs, and community development grant funding, we administer a variety of community potable water projects based on the concept of individual household sand filters. We employ local workers to oversee the work, construct and install the filters, and provide followup repair and public education in use and maintenance. We have also been working with the University of Illinois Engineers Without Borders chapter to research improvements and long term viability of the potable water program. We have placed almost 500 individual filters in households located in 8 service communities.

Salary and any benefits are formalized at a regularly scheduled Board Meeting and voted on by a simple majority of the Board. Employment terms and compensation is then formalized into an employment contract and executed by both parties. The majority of compensated employees are Guatemalan nationals. Compensation, additional tax payments, accounting, and employee benefits are provided in strict accordance with applicable Guatemalan regulations and labor policies.

PART XI RECONCILIATION OF NET ASSETS ITEM 5: Other changes in net assets includes the purchase of land in Guatemala and the construction of a combined medical clinic and community training center. This is the first year that the corporation has owned reportable assets in Guatemala. There was also a year-end reconciliation of the various program accounting funds to account for discrepancies in fund totals associated with fluctuating exchange rate between the US Dollar and the Guatemalan Quetzal.

PART XII FINANCIAL STATEMENTS AND REPORTING:

ITEM 2a: No level of financial audit has been completed for the organization since its inception due to the limited extent of its revenues and expenses. However that has significantly expanded during the reporting year 2011 and the Board of Directors is in the process of reviewing accounting policies and procedures and contracting with a CPA to complete a compilation of the 2011 accounting records.
