Also in 2012 VFA began a partnership with Vermont Technical College. Through this program there were 11 students during the fall semester who participated in taking their private training at Vermont Flight Academy. During 2012 the fleet grew to 12 planes, one of which was donated and another in which we have a 50% ownership in Lawn Dart Flyers, LLC. The remaining planes are a result of a lease back agreement with the planes owners.**
