YATST's mission is to increase student engagement in learning and voice in decision-making by creating partnership among students, faculty and community; to increase relevance, relationships, rigor and shared responsibility in Vermont schools. Participating schools agree to:

- 1) Create a youth-adult team which will commit to this work for at least two years. Students on the team being representative of the general student population,
- 2) Embed this initiative within the school day to the greatest extent possible,
- 3) Participate in multi-school retreats for training and team planning purposes,
- 4) Adult members enroll in an associated graduate-level course, and
- 5) Institutionalize this working group so it becomes part of the school decision-making process.
