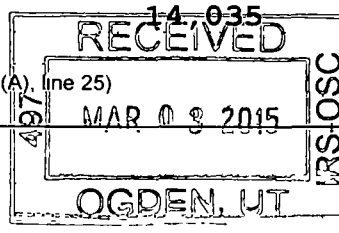

EarthWalk Vermont's mission is to inspire and empower children, families and communities to reconnect with and care for one another and the Earth through long-term community and nature-based mentoring. To that end, the organization enrolled 64 students between the ages of 7 and 12 during the school year in its Earthwalk Village school, a full day program that meets weekly. The Teen Land Project, a full day program meeting throughout the academic school year enrolled 13 students. After school programs had an enrollment of 24 students between the ages of 8 and 12 while the summer camps program enrolled 160 children. The Earthwalk Institute program, designed to train teachers of all sorts to learn cultural and nature mentoring for children enrolled 100. Continued on Schedule O
