The Park-McCullough House is one of the most significant and best preserved Victorian Mansions in New England. Built in 1864-65 by attorney and entrepreneur Trevor Park (1823 - 1882), The House was designed by Henry Dudley, a prolific New York architect of the popular firm of Diaper and Dudley. It is an important example of a country house in the Second Empire Style and incorporates architectural features of the Romantic Revival style that were popular at the time. To a great extent, the House retains the integrity and impact of its original design. In addition, original casework and furniture, paintings, as well as period dress, lace, toys, kitchen and dining room fittings remain in place. The property also includes a playhouse, a miniature of the Mansion itself; a Carriage Barn with a collection of horse-drawn carriages and sleighs; and extensive lawns and gardens.
