GRS' INNOVATIVE "SKILLZ TOURNAMENT" INTERVENTION IS AIMED AT GATHERING A LARGE NUMBER OF COMMUNITY MEMBERS WHILE PROMOTING TESTING, COUNSELING AND KNOW YOUR STATUS MESSAGES. USING THE POWER OF SOCCER AS A TOOL TO BRING YOUTH TOGETHER, THESE EVENTS INCREASE AWARENESS ABOUT HIV TESTING AND TREATMENT SERVICES AND EMPOWER YOUTH TO KNOW THEIR STATUS BY PROMOTING POSITIVE PEER PRESSURE. ONSITE RAPID HIV TESTING AND IMMEDIATE ENROLLMENT INTO CARE AND TREATMENT PROVIDED BY TRUSTED PARTNERS BRIDGES THE GAP BETWEEN HIV PREVENTION AND TREATMENT SERVICES, AND DEMONSTRATES THE POWER OF COLLECTIVE ACTION IN COMMUNITIES.
