VI. B. 11b. The Form 990 and supplemental Schedule O are prepared by the Treasurer and are reviewed by the Board of Governors at a
regularly scheduled meeting prior to filing. Unless there are concerns expressed by any Board member, the Treasurer files the return.

A copy is provided to the Audit Committee.

VI. B. 19. The Club does not regularly make its governing documents, conflict of interest policy or financial documents available to the
public. As required by the law, the public portion of the tax return is available for public review, but no request for this document has been
made by a member of the public in recent history.
