Programs - a series of guided walks on Pinnacle lands were held on the second weekend of every month from May through November. Led by Trustees, the purpose of these "Weekend Strolls" is to acquaint the public with new or rarely used trails, point out special features of the area, and reinforce environmental values. Accessibility Day is held on the last weekend of September. This annual event provides rides to people who are unable to walk to the peaks.
- 4b (Code ) (Expenses \$ 1,000 including grants of \$ ) (Revenue \$ )  
Education - many local schools use the Pinnacle and the ridgeline for field trips, environmental studies and the place where students perform community service work projects such as improving trails and removing invasive species. We sponsor an education program in the 3rd and 4th grades in the Westminster schools (2). For this purpose we hired a Naturalist to work with the school(s) to develop a curriculum and to lead the field trips.
- 4c (Code ) (Expenses \$ 11,608 including grants of \$ ) (Revenue \$ )  
Stewardship of 1845 15 acres and 22+ miles of trails. Expenses are property taxes, liability insurance, trail and access road maintenance, and trail maps, brochures and other kiosk materials. Volunteers worked 1,650 hours on trail development and maintenance. The average value is \$15/hour (\$24,750) but it is not included on the tax return or in financial statements. Trail brochures in kiosks show trails, inform the public of rules for usage and give information about our organization.
