We continue to provide access to a Naturopathic Physician and Activities in order to keep our residents active in the local community. We are dedicated to whole person quality care and sustainable practices in a setting which is within walking distance of the Bristol Village core area.**

**In June 2013, Awakening Sanctuary purchased a 39 bed licensed Level III Residential Care Home in Burlington, VT. This facility is being run under the same mission and vision as the Home in Bristol, VT Acquisition of this facility will allow us to expand our research capacity in order to develop and prove our business model of elder care. Our goal is to provide research-based data that shows the physical and emotional benefits of our integrated programs on our senior population. We continue to provide a larger proportion of Medicaid beds in our area than any other facility while accomplishing our goals for whole person centered quality care.**

**This division of Awakening Sanctuary is dedicated to research and development of the education, training and research tools surrounding operation of our two Level III Care Homes. Since the Burlington, VT facility was purchased over 3 years ago, the income stream for this portion of Awakening Sanctuary is still being developed. The goal is for this portion of Awakening Sanctuary to generate income in 2016.**
