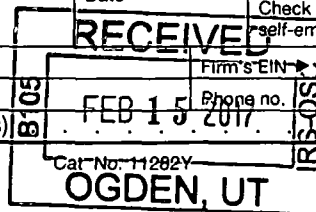
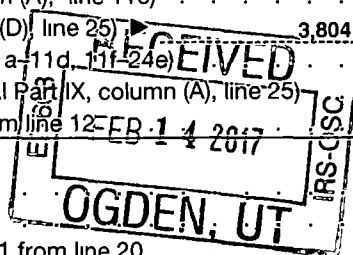

The mission of Have Justice-Will Travel, Inc. (HJVT) is to stop the generational cycle of abuse in rural American Families by bridging the legal, geographical, cultural, psychological, and economic gaps that exist for victims of family violence by providing free legal and social services, in home consultations, and transportation to victims and survivors of abuse. The best measure of HJVT's success is that 90% of the women served do not go on to or return to other abusive relationships.

The HJVT model is a holistic mobile, multi-service model that assists victims of domestic, sexual assault, dating violence, and stalking by providing them with free legal representation, safety planning and supportive social services. A continuum of in-office and on-the-road services is offered by HJVT for victims that allow them to understand the roots of the abuse for themselves and their children. HJVT provides free legal representation for protection order hearings and all family law matters, probate, and other civil legal matters. Transportation to and from court hearings and in-home consultations are provided as are other social services. 1,260 calls for legal representation were received by all HJVT offices from July 1, 2015 to June 30, 2016. Out of the 1,260 calls, 123 became LEAP clients and 73 full representation clients. LEAP offers legal advice and direction throughout the development of the client's case. It meets the needs of many disadvantaged Vermonters for whom HJVT cannot provide full representation because of limited number of attorneys HJVT is able to employ under current funding. Legal and social services are provided with matters such as relief from abuse, divorce, child support, visitation, and guardianship. Both telephone and in-person assistance is provided under the Legal Empowerment Assistance Program (LEAP). In addition to 1 attorney, 1 legal intern, and 1 administrative assistant, who are paid employees, HJVT has several law student interns volunteer each year.

4b (Code: Southern) (Expenses \$ 104,900 including grants of \$ 146,000) (Revenue \$ 0)

HJVT has a Southern Vermont office in Bennington which serves Bennington and Rutland counties. The office is staffed by a full time experienced attorney and is located in town for easy access for clients as well as providing on-the-road services for more rural clients. The office provided services for 125 full service and 23 LEAP clients during the fiscal year. The attorney also travels to Rutland county which is the county adjacent to and north of Bennington once a week to provide legal advice and legal representation in the courtroom for clients who are requesting relief from abuse orders and other family court matters that they have. Rutland County grants the highest numbers in protective orders of any county in Vermont. This office is also staffed with a part-time paralegal/client service coordinator. HJVT provides legal assistance to 50% of all victims that asked for a protective order in Southern Vermont. The southern office received a total of 306 calls from July 1, 2015 to June 30, 2016. The HJVT Southern office is funded by a three year grant from the US DOJ Office of Violence Against Women. The HJVT Southern office is funded by a 3 year grant from the US DOJ office of Violence Against Women.

HJVT operates a 3/4 office in the Northeast Kingdom area in Vermont which serves Caledonia, Essex, Lamoille, and Orleans counties. The NEK office is located on property that was donated to HJVT in January 2006. This office is staffed by an attorney who receives assistance from one of the paralegal client services coordinators who is housed in the Vershire, Vermont office. With a total of 232 calls, the staff attorney provided full legal and social services for 6 clients, and 101 families were provided with over the phone consulting services from HJVT Legal Empowerment Assistance Program, (LEAP). During this period the staff attorney worked on a variety of cases including relief from abuse, divorce, parentage, child support, parental rights and responsibilities and parent child contact. In addition there are a number of cases in Probate Court where extended family members seek guardianship of children. The Northeast Kingdom is the most rural and disadvantaged area in Vermont. Isolated living conditions and severely restricted resources combines with poverty, unemployment, and limited literacy, create a daunting set of obstacles for people trying to leave abusive situations.
