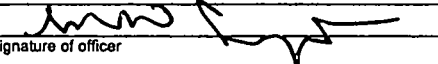
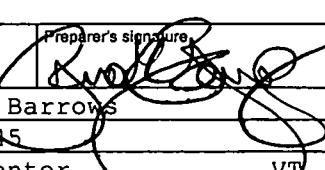

Public Library with 10,990 visitors, borrowing 11,124 materials. We circulated State-owned titles, LARGE TYPE books, videos and audiobooks, and downloaded 225 e-books and 825 audio books. We made 90 requests for inter-library loans, and sent out our materials on 10 occasions. The library hosted numerous community meetings, talks, art openings, and other similar events during the year. We also served more than 880 children and adults with our weekly story hours, lunchtime reading programs, and book discussion groups. The library also provides wi-fi internet access, and a bank of computers available to the public which were used more than 1,000 times in 2015. The Library's Teen Space offers an after-school hangout for school-aged youth every afternoon.
