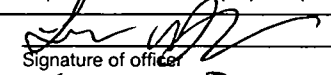

Sandglass toured "D-Generation..." in Illinois, Montana, Wyoming, Wisconsin, Tennessee, Georgia, as well as London, England. Sandglass toured "Autumn Portraits" in Scotland. Sandglass toured "Punschi" in Vermont, New Hampshire, Massachusetts, and New York. Sandglass collaborated with a puppet company in El Salvador on creating a show "Nathan the Wise." Sandglass had an exhibit and gave a lecture at University of Connecticut.

At its local theater in Putney, VT, Sandglass presented its 2015 installments of its 4 annual series: "Voices of Community," "New Visions," "Winter Sunshine," and "Music in June."
